WHEREAS, the Missouri Department of Natural Resources has requested that the City designate individuals authorized to execute documents on behalf of Kansas City, Missouri; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That, on behalf of the City, the Director, Chief Engineering Officer and Chief Financial Officer of the Water Services Department are hereby authorized to apply for and accept the terms and conditions of the Missouri State Revolving Fund Program and to officially execute, provide necessary and required documentation required to administer the program for the Water Services Department and receive payment on behalf of the City.
