Directing the City Manager to enter into a funding agreement with KC2026 in the amount of \$15 million over a three-year period for the purpose of providing City services at the 2026 FIFA World Cup; estimating revenue in the amount of \$4,675,000.00 for short-term rentals; appropriating \$5 million from the Unappropriated Fund Balance of the Convention and Tourism Fund; directing the City Manager to include equal appropriations of \$5 million in the Submitted Budgets for FY 2024-25 and FY 2025-26 to satisfy the terms of the agreement; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, through Ordinance No. 170979 and Committee Substitute for Ordinance No. 171005, the City Council declared its intent to fund certain City services in connection with the 2026 FIFA World Cup; and

WHEREAS, in an election held on April 4, 2023, the qualified voters of the City approved a 7.5% tax on the gross receipts of short-term rentals and a \$3.00 occupancy fee on the hotels, motels, tourist courts, and short-term rentals in the City; and

WHEREAS, expected revenue from the new taxes makes possible the use of the Hotel portion of the Convention and Tourism Tax for the purpose of funding the City's contribution to the 2026 FIFA World Cup; and

WHEREAS the economic impact of the World Cup is estimated by the Kansas City Sports Commission at \$652.6 million; and

WHEREAS it is estimated that the tax revenue generated for Kansas City from the World Cup will be \$35 million; and

WHEREAS, the City's contribution to the World Cup is not to exceed \$15 million to be funded in equal installments of \$5 million each over three (3) fiscal years beginning in Fiscal Year 2023-24; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is hereby authorized and directed to negotiate a funding agreement with KC2026, a Missouri 501(c)(4) nonprofit corporation, in the amount of \$15 million, for the purpose of providing the necessary City services including police, fire, traffic,

EMS and sanitation services, and all other contractual obligations for the 2026 FIFA World Cup games that will be played in Kansas City, as well as all related events and activities, subject to final Council approval and appropriation. The City Manager shall agree, at minimum, to the following terms:

- The agreement shall dedicate no more than \$15 million from the City, allocated equally over a three-year period and subject to appropriation;
- The City shall use funds derived exclusively from the revenues collected pursuant to the hotel portion of the Convention and Tourism Tax (Code Sec. 68-551(a)(1)).

Section 2. That revenue in the amount of \$3,100,000.00 is hereby estimated in the Convention and Tourism fund to the following account:

Section 4. That the sum of \$5,000,000.00 is hereby appropriated from the unappropriated fund balance of the Convention and Tourism Fund to the following account:

Section 5. That the Director of Convention and Entertainment Facilities is hereby designated as requisitioning authority for Account No. 24-2360-632050-B.

Section 6. That the City Manager is directed to include an appropriation of \$5,000,000.00 from the Convention and Tourism Fund in each of the Submitted Budgets for FY 2024-25 and FY 2025-26 to satisfy the terms of the agreement authorized in Section 1.

Section 7. That this ordinance is recognized as an ordinance with an accelerated effective date as provided by Section 503(a)(3)(C) of the City Charter in that it appropriates money, and shall take effect in accordance with that section.

This ordinance authorizes and directs the City Manager to enter into a funding agreement with KC2026, a Missouri 501(c)(4) nonprofit corporation, in the amount of \$15 million, for the purpose of providing the necessary City services including police, fire, traffic, EMS and sanitation services, and Airport services for the 2026 FIFA World Cup games that will be played in Kansas City, as well as all related events and activities, subject to appropriation. The City Manager shall agree, at minimum, to the following terms:

- The agreement shall dedicate no more than \$15 million from the City, allocated equally over a three-year period, subject to appropriation;
- The City shall use funds derived exclusively from the revenues collected deposited into the Convention and Tourism Fund.

Revenue is estimated totaling \$4.675 million- \$3,100,000 to be deposited in 24-2360-120000-454115, another \$1,575,000 to be deposited in 24-2360-120000-452520, while \$5 million is being appropriated from the unappropriated balance of the Convention and Tourism fund.

Authorizing the City Manager to execute an amendment to the existing agreement with the Convention and Visitors Bureau of Greater Kansas City, Inc., d/b/a Visit KC.

WHEREAS, Ordinance No. 200833 authorized the Director of the Convention and Entertainment Facilities Department to enter into a five (5) year agreement commencing on May 1, 2021, with the Convention and Visitors Bureau of Greater Kansas City, Inc., d/b/a Visit KC, a corporation formed and existing under Chapter 355, RSMO, to provide services for the promotion of convention and tourism business within the city with a one (1) year option to renew at the City's option; and

WHEREAS, in an election on April 4, 2023, the qualified voters of the City authorized an additional One Dollar and Fifty Cent (\$1.50) license fee on hotels, motels, and tourist courts, and imposed a like fee on short-term rentals in the City; and

WHEREAS, in the same election on April 4, 2023, the qualified voters of the City also authorized imposition of a Transient Boarding and Accommodation Tax of seven and one-half percent (7.5%) to all lodging establishments, including short-term rentals not otherwise subject to the City's Convention and Tourism Tax; and

WHEREAS, the City now desires to use a portion of its new convention and tourism related funds to enhance marketing and promotion of the City while retaining flexibility to fully fund its obligations for other convention and tourism purposes including the 2026 World Cup during the balance of the contract term; and

WHEREAS, as part of the contract amendment, the City shall provide not less than forty percent (40%) of the funds derived from the Convention and Tourism tax to VisitKC, to be effective May 1, 2026 through April 30, 2027; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is hereby authorized to amend the current five (5) year agreement with the Convention and Visitors Bureau of Greater Kansas City, Inc., d/b/a Visit KC for the promotion of convention and tourism business within Kansas City, Missouri by providing additional funding equivalent to the excess revenues collected from the City's Convention and

Tourism Tax, beyond the City's \$5 million annual commitment to the 2026 FIFA World Cup. The City Manager shall agree, at minimum, to the following terms:

- a) That effective August 1, 2023 through April 30, 2026, the City shall contribute to VisitKC the additional tax revenue collected in excess of \$5 million from the Convention and Tourism Tax (Code Sec. 68-551) and the Transient Boarding and Accommodation Tax (Code Sec. 68-586), as well as the unencumbered revenues collected from the Hotel, Motel, and Tourist Court occupancy fee (Code Sec. 40-111) and the Short-Term Rental occupancy fee (Code Sec. 40-168) to be paid in equal monthly installments, subject to verification of FY 2023-24 actual collections;
- b) That effective January 1, 2024, the Board of Directors for VisitKC shall not exceed eleven (11) members with five (5) members to be appointed by the Mayor and six (6) to be appointed by Visit KC.
- c) The amended contract shall expire on April 30, 2027.

Executive Summary

Authorizing the City Manager to execute an amendment to the existing agreement with the Convention and Visitors Bureau of Greater Kansas City, Inc., d/b/a Visit KC.

Discussion

This legislation amends the agreement with Visit KC, to provide additional funding via Transient Boarding and Short-Term Rental revenues in excess of the City's \$5 million commitment for the 2026 FIFA World Cup.

Effective August 1, 2023, through April 30, 2024, the City will contribute to Visit KC additional tax revenue collected in excess of \$5 million from the Transient Boarding and Accomodation tax as well as the excess of the 50% of Short-Term Rental occupancy fee dedicated to convention and tourism purposes. Totals are subject to verification of actual collections.

Effective May 1, 2024, through April 30, 2025, the City will contribute to Visit KC additional tax revenue collected in excess of \$5.325 million from the Transient Boarding and Accommodation tax as well as the excess of the 50% of Short-Term Rental occupancy fee dedicated to convention and tourism purposes. Totals are subject to verification of actual collections.

Effective May 1, 2025, through April 30, 2026, the City will contribute to Visit KC additional tax revenue collected in excess of \$5 million from the Transient Boarding and Accommodation tax as well as the excess of the 50% of Short-Term Rental occupancy fee dedicated to convention and tourism purposes. Totals are subject to verification of actual collections.

Effective May 1, 2026, through April 30, 2027, the City shall provide to Visit KC no less than 40% of funds derived from the hotel portion of the Convention and Tourism Tax.

Discussion

<u>Project Justification</u>: In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States EPA to reduce wet weather overflows from the City's sewer systems. The City's Smart Sewer Program is currently in year 13 of a 30-year implementation period. This project will provide consent decree modification and compliance services to assist the City with seeking its fourth consent decree modification from the US Environmental Protection Agency to address projected changes in the City's financial circumstances. Pending new regulatory compliance obligations involving changes in the City's NPDES permit will result in additional compliance costs which will adversely impact the City's current funding plan for Consent Decree projects.

<u>Project Description:</u> The scope of services to be performed under this contract includes the following supplemental program management services:

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system over a 25-year period. In March 2021, the Consent Decree was modified to include additional interim and revised final performance criteria and to extend its duration to 30 years. This project will provide consent decree modification and compliance services to assist the City with seeking its fourth consent decree modification from the US Environmental Protection Agency to address projected changes in the City's financial circumstances.

Other Impacts

1. What will be the potential health impacts to any affected groups?

This project will provide program management supplemental services to assist the City in seeking a consent decree modification to address long-term compliance cost



affordability concerns while meeting the requirements of the Consent Decree to improve the performance, capacity, and reliability of the City's sewer system, thereby reducing sewer overflows, protecting public health, and improving water quality of local streams and rivers.

2. How have those groups been engaged and involved in the development of this ordinance?

The 2020 – 2024 Adopted Citywide Business Plan includes the development of environmentally sound and sustainable infrastructure strategies and a tactic to reduce financial impacts of the City's Smart Sewer Program by proactively working with the EPA to adjust the timeline for project completion. Obtaining input from City leadership will be essential prior to submittal of the City's proposed consent decree modification to EPA for approval.

3. How does this legislation contribute to a sustainable Kansas City?

This project helps promote environmental quality, social equity, economic vitality, and financially sustainable infrastructure investments.

4. Does the ordinance/resolution include Civil Rights antidiscrimination requirements in compliance with the Code of Ordinances (Chapter 38, titled "Civil Rights")?

Resolution designating the City of Kansas City as the recipient of the USDOT Raise 2022 Grant for the US 71 corridor.

Discussion

The RAISE grant will be used to study the US-71 corridor from 85th Street north to Dr. Martin Luther King Jr. Boulevard. This portion of US-71 has the highest numbers of severe injury and fatal crashes for pedestrians and cyclists in the Kansas City metro region and is a significant barrier to east/west travel for non-motorized travel. The US-71 Reconnecting Neighborhoods Project will identify detailed goals and objectives, assess a range of alternatives, arrive at a community supported preferred alternative, and advance the project into environmental analysis and preliminary design that will improve the safety and accessibility of the highway for all users.

Originally the City of Kansas City was the direct recipient of the RAISE grant, but after discussions with MoDOT and FHWA it was thought that MoDOT may perhaps be the better administrator of the grant. On February 3rd, 2023 a letter from the City officially requested MoDOT be designated the recipient of the grant. However, since that time it has become evident that under the proposed arrangement the City of Kansas City would not be able to directly manage the design consultant contract and therefore would lack sufficient authority to direct the work product and assure the community needs were met. The City of Kansas City therefore respectfully requests that we revert back to the original agreement with the City of Kansas City being the direct recipient.

WHEREAS, currently Section 2-970.6 of the City's Code of Ordinances provides that the Board of Parks and Recreation Commissioners has the authority to designate the directors of the Kansas City Museum Foundation with the Mayor's approval and the Parks Board also has the authority to designate the chairperson and vice-chairperson of the Foundation and to amend the articles of incorporation and bylaws; and

WHEREAS, on June 13, 2023, the Board of Parks and Recreation Commissioners passed Resolution No. 32260 recommending to the City Council that it amend Section 2-970.6 of the City's Code of Ordinances to reflect that the Kansas City Museum Foundation is a self-perpetuating board of directors capable of appointing its own board and officers and amending its own articles of incorporation and bylaws; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 2, Code of Ordinances of the City of Kansas City, Missouri, is hereby amended by repealing Section 2-970.6 Kansas City Museum Foundation, Inc., and enacting in lieu thereof a new section of like number and subject matter, to read as follows:

Sec. 2-970.6. Kansas City Museum Foundation, Inc.

- (a) *Purpose*. The purposes of the Kansas City Museum Foundation, Inc. include:
- (1) To raise funds to support, maintain and increase the collections and exhibits of the Kansas City Museum;

- (2) To sponsor programs, exhibitions and events, including, but not limited to, the development and preservation of the buildings and/or collections;
- (3) To participate in and conduct programs in support of educational and similar activities related to either the buildings and/or grounds or other related purposes;
- (4) To advise on and support the implementation of the renovation of and/or improvements to the Kansas City Museum (including in each situation both the building and grounds and other supporting areas);
- (5) To preserve and display the collections held by the Kansas City Museum (including other supporting areas); and
- (6) To create and implement the strategic plan for the Kansas City Museum.
- (b) Establishment, membership, appointment of directors. The articles of incorporation of the Kansas City Museum, Inc. (hereinafter "Foundation") shall be amended and restated as follows: The board of directors of the Foundation shall be composed of between 3-15 members and they shall be self-perpetuating. The Foundation shall adopt such articles of incorporation and bylaws as it deems necessary to effectuate its purposes and govern its affairs.
 - (1) One of the members of the Foundation board (hereinafter "Board") shall be a member of the Board of Parks and Recreation Commissioners.
 - (2) The Foundation shall endeavor to choose representatives of organizations with stakeholder interests in the Kansas City Museum including civic leaders and associations that will further the purposes of the Foundation.
 - (3) Each director shall be appointed for a three-year term. The terms shall be staggered.
 - (4) A quorum shall be determined by the bylaws.
- (c) Officers and meetings. The officers and meetings shall be determined by the Foundation bylaws.
- (d) Parks department liaison. The Parks and Recreation Department will provide a liaison to the Foundation.
- (e) Meetings; rules and procedures. The Foundation Board shall have the authority to amend or adopt, from time to time, the articles of incorporation, bylaws, rules and regulations as it may deem necessary to effectuate its purpose and govern its affairs.

The amendments proposed by Ordinance No. 230543 would remove the legal requirement that:

WHEREAS, the City of Kansas City, Missouri ("City") and the Port Authority of Kansas City, Missouri ("Port KC") are political subdivisions of the State of Missouri and are authorized to accept, receive, transfer and convey real property, and to cooperate with each other to accomplish their purposes; and

WHEREAS, City currently owns real property located in the River Market and generally bounded by 3rd Street on the north, 4th Street on the South, Main Street on the east, and an access alley on the west ("Subject Property"); and

WHEREAS, the Subject Property is currently being leased to the Planned Industrial Expansion Authority until 2025; and

WHEREAS, the City has agreed to transfer real property immediately to the south of the Subject Property to Port KC, pursuant to Committee Substitute for Ordinance No. 200227, in furtherance of a residential and commercial development known as "Bellwether"; and

WHEREAS, the Council has determined that the Subject Property is not needed for public use; and

WHEREAS, the Subject Property is currently utilized as a greenspace and, while not a public park maintained by the Parks & Recreation Department, is commonly referred to as "City Market Park"; and

WHEREAS, the development terms for the Bellwether project provide that City Market Park will be used, in part, as a laydown yard during construction, after which it will continue to be used as public greenspace; and

WHEREAS, Port KC has proposed to operate and maintain, or cause a third party to operate and maintain, the public greenspace following completion of the Bellwether project, thereby preserving the same as a public amenity; and

WHEREAS, the City Council has determined that ownership of the public greenspace by or through Port KC is in the public interest as Port KC's investments in and abutting this area provide an incentive for ensuring that the greenspace is well-maintained; and

WHEREAS, the ownership and maintenance of the greenspace by or through Port KC will allow the City Council to achieve its objectives with respect to the River Market neighborhood while also freeing resources that the City would have otherwise expended for other public endeavors; NOW THEREFORE,
