WHEREAS, the City of Mosby, Missouri desires to contract for a maximum quantity of 0.6 million gallons per day (MGD), allocated to one point of service; and

WHEREAS, the City of Mosby, Missouri agrees to construct, at City of Mosby's expense, a metering/regulating facility to purchase water from Kansas City, Missouri; and

WHEREAS, the City of Mosby, Missouri will be responsible for the capital costs for connection to Kansas City's Main near Highway 69 and Rhodus Road, including but not limited to any line extensions, easements, permits, master meter, meter pit and connection fees; and

WHEREAS, Kansas City, Missouri is willing to deliver and sell water to the City of Mosby, Missouri in accordance with the terms and conditions set forth herein; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Water Services is hereby authorized to execute, on behalf of Kansas City, a Cooperative Agreement for Water Purchase between the City of Mosby, Missouri and Kansas City, Missouri, for a period of twenty-five (25) years. Executive Summary

Authorizing a \$1,020,000.00 design professional services contract with Black & Veatch Corporation, for Renewal No. 1 for the Water and Wastewater Operations and Maintenance Assistance project; and authorizing four successive one-year renewals with further City Council approval.

Discussion

Reason for Contract

Water Services is undertaking this project to improve operational and maintenance efficiency at Kansas City's (1) Water Treatment Plant (WTP), (6) Wastewater Plants (WWTP's) and the pump stations that move flow to and from those plants. This project will also assist the Regulatory Compliance Division with researching and reviewing Federal and State regulations pertaining to WTP/WWTP operations. The project will focus on upgrading standard operational and maintenance procedures, implementing effective process control decision making, integrate Hansen work control information with facility reliability centered maintenance activities and support staff training at all organizational levels.

This contract will help operations and maintenance staff to build upon current work practices and find new ways to look at plant decision making. The Consultant will provide hands-on support to implement work practices which prevent non-compliance with National Permit Discharge Elimination System (NPDES) standards and improve overall treatment plant equipment/system reliability.

Ordinance No. 230558 was approved by City Council on July 13, 2023 approving the original \$1,270,000.00 design professional services contract with Black & Veatch Corporation for the Water and Wastewater Operations and Maintenance Assistance project. The City executed the original contract on September 14, 2023.

The contract will have a total of five (5) renewal options. This proposed ordinance is for the first renewal option. Each will require City Council approval.

Project Description

Services provided under this contract will center on updating facility standard operational and maintenance procedures, implementing Process Control Management Plans (PCMP) at all remaining treatment plants, auditing current work practices to ensure they are being conducted in compliance with procedures and policies, implement reliability centered maintenance activities at all treatment plants and pump stations, integrate Hansen work control data and plant performance metrics and provide hands on training to plant staff where new work practices or procedures are developed.

This project is located at Water and Wastewater Treatment Plants and Pump Stations in Kansas City, Clay, Jackson, and Platte Counties, Missouri.

Term

The term of this project will be 365 calendar days with four remaining 365-day renewals, out of a total of five possible renewals.

Solicitation

This project was advertised in accordance with the City's requirements on December 13, 2022, and proposals were received on January 27, 2023 with two (2) consultants responding.

Awardee/Subcontracting Participation

For selection of the consultant on this project, a City-Wide Selection Committee met and consisted of the following individuals:

- Wes Minder, Water Services Department Director
- Eric Bunch, 4th District Councilperson
- Morgan Holecek, City Manager's Office

Black & Veatch Corporation was selected for this project with a contract amount of \$1,270,000.00, with subcontracting participation of 14% MBE and 14% WBE.
