WHEREAS, the City has contracts with Johnson County, Missouri and Vernon County Missouri to provide detention services; and

WHEREAS, the City has inadequate opportunities for rehabilitation and detention services including substance abuse treatment, mental health and public safety; and

WHEREAS, the purpose of a City rehabilitation and detention center is to deter and prevent future harm; and

WHEREAS, the purpose of a City rehabilitation and detention center is also to provide comprehensive

programming that aids in breaking the cycle of addiction and poverty; and

WHEREAS, the City needs to have a long-term solution to provide opportunities for rehabilitation and detention services including substance abuse treatment, mental health and public safety; NOW, THEREFORE,

## BE IT RESOLVED BY THE COUNCIL OF KANSAS CITY:

- Section 1. That the City Manager is directed to negotiate with Jackson County to partner in providing effective rehabilitation and detention services in the Jackson County New Detention Center Campus.
- Section 2. That the City Manager is directed, in collaboration with the City Council and the Jackson County Legislature, to present a status report to the Council relating to the joint efforts of the City and County to construct and operate a jail within 30 days of the effective date of this resolution.
- Section 3. That the City Manager and Mayor will appoint staff and City Council member to a joint City and County Steering Committee for the construction and operation of the jail.
