Authorizing a lease with Southwest Airlines Company at the Kansas City International Airport. Contract No. 6223020025; and estimating revenue in the amount of \$105,361.47.

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Aviation is hereby authorized to execute a lease with Southwest Airlines Company at the Kansas City International Airport for Office/Warehouse Space at the MCI Air Cargo Center 1 Facility with the lease term beginning August 1, 2023 and ending July 31, 2026, with the option for one (1) additional two-year period. A copy of the lease is on file in the Office of the City Clerk.
